



Endorsements for the Educational Choice for Children Act (ECCA) (S.120; H.R.531)

The ***Educational Choice for Children Act (ECCA)***, introduced in January 2023, is the leading bill in Congress for the advancement of parental choice in education. The ECCA would provide \$10 billion in annual tax credits for individual and corporate donations to K-12 Scholarship Granting Organizations (SGOs). Up to 2 million students could benefit, which would triple the number of students currently enrolled in private school choice programs. The bill provides for broad family eligibility, as students who would be in any elementary or secondary education setting, including homeschool, are eligible to receive a scholarship, provided they reside in households with incomes at or below 300 percent of the federal median income standard. Students in every state would be eligible, which would complement and expand existing school choice offerings in 31 states and bring real school choice to the other 19 states. Bill sponsors are Senators Bill Cassidy (LA) and Tim Scott (SC) (S.120) and Representatives Adrian Smith (NE) and Burgess Owens (UT) (H.R.531).
